EFFORTS ON PEACE AND DEVELOPMENT AND CREATE DISASTER-RESILIENT COMMUNITIES, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO". The said resolution was enacted by the 16th Sangguniang Panlalawigan on April 13, 2022;

WHEREAS, Commissioner Gamaliel A.
