**A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2022-07, OF THE SANGGUNIANG BAYAN OF LUPON, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE DECLARING A PORTION ALONG SUMLOG RIVER AND TAGUGPO RIVER AS SAND AND GRAVEL RESERVE BUFFER ZONE, BEGINNING FROM THE NIA IRRIGATION DAM IN BARANGAY TAGUGPO AND GOING UPSTREAM, INCLUDING BARANGAYS DON MARIANO MARCOS, CALAPAGAN AND MARAYAG, ALL OF THIS MUNICIPALITY, THEREBY DECLARING THE SAME AS SAND AND GRAVEL NO EXTRACTION ZONE”, CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.**

**WHEREAS**, Section 447(a)(1)(vi) of RA 7160 or the Local Government Code of 1991, states among others, that: “*The sangguniang bayan, as the legislative body of the municipality, shall protect the environment and impose appropriate penalties for acts which endanger the environment xxx*”;

**WHEREAS**, the Sangguniang Bayan of Lupon enacted the said Ordinance to protect and conserve the rich biodiversity of both Sumlog and Tagugpo Rivers;

**WHEREAS**, upon premises considered, it is the recommendation of the August Body to the Sangguniang Bayan, the reconsideration of the following in the implementation of the said ordinance, to wit:

1. Technical specifications such as geo-tagged specification in the sand and gravel buffer zone should be identified and indicated;
2. There shall be regular assessment in the hydrological aspect and the extraction which will form part in the institutional implementation and will be indorsed to the concerned agency such as the Mines and Geosciences Bureau for their technical assistance.
