A RESOLUTION FURTHER AMENDING SP RESOLUTION NO. 17-04-07-2022, SPECIFICALLY SECTION 7 OF RULE VII (COMMITTEES), BY ADDING A CLAUSE, "WHENEVER THERE IS A TEMPORARY VACANCY IN THE CHAIRMANSHIP OF ANY COMMITTEE, THE LAW OF SUCCESSION WILL APPLY".

WHEREAS, SP Resolution No. 17-04-07-2022, entitled: "A RESOLUTION PRESCRIBING THE INTERNAL RULES OF PROCEDURE OF THE 17<sup>TH</sup> SANGGUNIANG PANLALAWIGAN OF DAVAO ORIENTAL AND ITS TWENTY NINE (29) WORKING COMMITTEES AND FOR OTHER PURPOSES", was passed and approved by the 17<sup>th</sup> Sangguniang Panlalawigan of this Province on its 2<sup>nd</sup> regular session held on July 13, 2022;

**WHEREAS,** Rule VII of the said resolution is further amended by adding a clause on Section 7, and the same as amended shall now read as follows:

SECTION 7. Vacancy – Vacancy in a committee chairmanship shall be filled up by an election and an approved motion of all the members. Whenever there is a temporary vacancy in the chairmanship of any committee, the law of succession will apply.
