A RESOLUTION ENDORSING TO THE HONORABLE GOVERNOR CORAZON N. MALANYAON, THE HEREIN LETTERS OF THE FORMER PROVINCIAL GOVERNOR NELSON L. DAYANGHIRANG, RELATIVE TO HIS REQUEST TO THE 16TH SANGGUNIANG PANLALAWIGAN FOR THE PASSAGE OF RESOLUTIONS, FOR WHATEVER ACTION DEEMED APPROPRIATE THEREOF.

WHEREAS, the Former Provincial Governor Nelson L. Dayanghirang, in his letter dated January 6, 2022, forwarded a copy of the Certification dated December 6, 2021, duly signed by him, for reconsideration of his request on the passage of a resolution providing funds and undertake implementation of other components not covered by the National Housing Authority's assistance for contributions of other participating institution, through his previous letter dated June 11, 2021. The said pending resolution is among the requirements for the application of the P20 Million Pesos grant from the NHA's Housing Assistance Program for Indigenous Peoples

through a Memorandum of Agreement for the IP Housing in Sitio Maglahus, Brgy. PM Sobrecarey, Caraga, Davao Oriental;

WHEREAS, another letter, dated June 1, 2022, the former Governor requested for an authority, for and in behalf of the Provincial Government of Davao Oriental, to sign into a Deed of Donation for the Right of Way in favor to the NLD Oriental and NLD Homeowner's Association Community Mortgage Program (CMP) under Social Housing Finance Corporation (SHFC);

WHEREAS, the said requests were not acted upon by the 16<sup>th</sup> Sanggunian due to lack of required documents and the conclusion of the term of the previous council. The same were endorsed to the 17th Sangguniang Panlalawigan for appropriate action, through the Committee on Housing, Rural and Urban Development, and Land Utilization;

WHEREAS, this August Body believed that under the new administration with the new Provincial Governor, the request for authority to be granted to Former Provincial Governor Nelson L. Dayanghirang, now 1st District Representative of the province, is no longer applicable, hence, a need to endorse the same to the present Local Chief Executive, the Honorable Governor Corazon N. Malanyaon, for her perusal and whatever action deemed appropriate thereof;
