A RESOLUTION FORWARDING APPROPRIATION ORDINANCE NOS. 04, SERIES OF 2022, AND 2022-03 OF THE CITY OF MATI AND MUNICIPALITY OF BANAYBANAY, RESPECTIVELY, THIS PROVINCE, TO THE PROVINCIAL LOCAL FINANCE COMMITTEE, THROUGH THE PROVINCIAL BUDGET OFFICER, FOR TECHNICAL REVIEW AND APPROPRIATE RECOMMENDATION THEREOF, PURSUANT TO SECTION 316(f) OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Appropriation Ordinance No. 04, series of 2022, of the City of Mati, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 04, involving an appropriation of **One Hundred Fifteen Million Seven Hundred Twenty Seven Thousand Two Hundred Forty Six Pesos and 34/100 (P 115,727,246.34)**, was submitted to this Sanggunian for review on August 4, 2022, and the same was docketed as Communication No. 17-53-2022;

WHEREAS, Appropriation Ordinance No. 2022-03, of the Municipality of Banaybanay, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 03, involving an appropriation of **Nine Hundred Nine Thousand Six Hundred Fifty One Pesos and 2/100 (P 909,651.02)**, was submitted to this Sanggunian for review on August 9, 2022, and the same was docketed as Communication No. 17-58-2022;

WHEREAS, the subject Appropriation Ordinances were referred to the Committee on Finance, Budget & Appropriations on August 10, 2022, during the 6th Regular Session of the 17th Sangguniang Panlalawigan;

WHEREAS, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within 90 days from receipt of copies of such ordinance;

WHEREAS, the reglementary period of review of the foregoing Appropriation Ordinances will end on November 2, 2022, and November 7, 2022, respectively;

WHEREAS, Section 316(f) of the same Code provides that the Local Finance Committee shall assist the Sangguniang Panlalawigan in the review and evaluation of budget of component cities and municipalities xxx and recommend the appropriate action thereon;

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Harold A. Montes, Rotchie M. Ravelo, Daud V. Linsag, Stephen Paul L. Uy, Art Benjie C. Bulaong, and Anna Cheryl N. Castro, it was




