**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 01-2022 OF THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.**

**WHEREAS**, Appropriation Ordinance No. 01-2022 of the Municipality of Lupon, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 01, involving an appropriation of **Twenty Three Million Four Hundred Sixteen Thousand Eight Hundred Sixty Eight Pesos & 06/100 (P 23,416,868.06)**, was submitted to this Sanggunian for review on June 8, 2022, pursuant to the provisions of Republic Act No. 7160;

**THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:**

**RESOLVED**, to declare Appropriation Ordinance No. 01-2022, of the Municipality of Lupon, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- a.) Lump sum appropriation in Capital Outlay/Other MOOE/Other General Services, etc. shall be subject to Sections 305(b) and 335 of R.A. 7160, RA 9184 (Government Procurement Reform Act) and its Revised IRR, and other existing pertinent laws, rules and regulations imposing restraints on government expenditures.
- b.) Fund Appropriation for Economic Enterprise shall be in accordance with DBM LBC No. 100, dated October 1, 2012.

**RESOLVED FURTHER**, to inform the Municipality of Lupon, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Lupon, Davao Oriental, through the Municipal Mayor.


