A RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, HONORABLE CORAZON N. MALANYAON, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA), WITH THE DEPARTMENT OF AGRICULTURE – REGIONAL FIELD OFFICE XI (DA-RFO XI), REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR, MR. ABEL JAMES I. MONTEAGUDO, RELATIVE TO THE PROVISION OF ONE (1) ELECTRIC STUNNER WITH PORTABLE GENERATOR FOR THE CONTROL AND PREVENTION OF AFRICAN SWINE FEVER IN THE PROVINCE.

**WHEREAS**, the Governor, Honorable Corazon N. Malanyaon, requested the August Body for an authority to enter into a Memorandum of Agreement with the Department of Agriculture – Regional Field Office XI, for the provision of the necessary equipment to control and prevent the African Swine Fever;

**WHEREAS**, there are existing task forces in the LGUs that implement ASF disease control measures. However, it requires necessary equipment to implement humane depopulation, specifically the humane culling of ASF-affected animals as provided in RA 8485 or the Animal Welfare Act of 1998, and at the same time reducing further contamination in the affected areas;

**WHEREAS**, an Electric Stunner with portable generator is a vital equipment for humane culling of ASF-affected pigs and for the disinfection in different animal quarantine checkpoints for entry and exit points in the region;

**WHEREAS**, pursuant to Section 465(b)(1)(vi) of the Local Government Code of 1991 which provides for the duty and function of the Provincial Governor to *“represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance”*;

**WHEREFORE**, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Daud V. Linsag, Harold A. Montes, Marietta D. Palmera, Art Benjie C. Bulaong, and Stephen Paul L. Uy, it was


