A RESOLUTION CONFIRMING THE VALIDITY OF EXECUTIVE ORDER NO. 63, SERIES OF 2022, ISSUED BY THE HONORABLE MICHELLE N. RABAT, CITY MAYOR OF MATI, DAVAO ORIENTAL, RE: “PRESCRIBING GUIDELINES FOR THE OPERATION OF A NIGHT MARKET ADJACENT TO THE MAYOR FRANCISCO G. RABAT PARK AND BAYWALK UNTIL DECEMBER 31, 2022”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE CITY MAYOR PURSUANT TO ARTICLE I, SECTION 455(b)(2)(iii) OF THE LOCAL GOVERNMENT CODE OF 1991 OR REPUBLIC ACT 7160.

WHEREAS, Section 455(b)(2)(iii) provides that: *“the city mayor, as chief executive of the city government, shall issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances”*,

WHEREAS, City Mayor Michelle N. Rabat issued Executive Order No. 63, series of 2022, on the 1st day of August, 2022, to establish and enforce guidelines for the operation of a night market thereof, and to deter obstructions to the beauty and
