WHEREAS, Section 4 of Republic Act No. 7719, otherwise known as the “National Blood Services Act of 1994”, provides that: *“in order to ensure adequate supply of human blood, voluntary blood donation shall be promoted”*;

WHEREAS, the City Government of Mati endeavors to establish a Blood Donors’ Program to provide adequate, safe and affordable supply of blood in every barangay by
