**A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 538, SERIES OF 2022, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE CREATING THE POSITION OF SENIOR ADMINISTRATIVE ASSISTANT V (SG-18) OF MATI PUBLIC MARKET, CITY OF MATI”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD PURSUANT TO ARTICLE III, SECTION 458(a)(1) OF R.A 7160, OR THE LOCAL GOVERNMENT CODE OF 1991.**

**WHEREAS**, the Sangguniang Panlungsod of Mati, Davao Oriental, submitted City Ordinance No. 538, series of 2022, last August 17, 2022, for review of the Sangguniang Panlalawigan;

**WHEREAS**, the enactment of the subject City Ordinance is necessary in order to augment the services of the Mati Public Market in the City of Mati;

**WHEREAS**, Article III, Section 468(a)(1)(i) of RA 7160, provides for the legal basis of the Sangguniang Panlalawigan to “review all ordinances approved by the sanggunians of component cities and municipalities to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor”, among others, the foregoing City Ordinance is in accordance with law;


