WHEREAS, the Sangguniang Bayan of Caraga, Davao Oriental, submitted Municipal Ordinance No. 01-A, series of 2022, last August 18, 2022, for review of the Sangguniang Panlalawigan;

WHEREAS, the Civil Service Commission (CSC) promulgated Resolution No. 071813, which declares various coterminous positions to be primarily confidential positions, which under existing rules, are exempted from the qualification standards;

WHEREAS, Article III Section 468(a)(1)(i) of RA 7160, provides for the legal basis of the Sangguniang Panlalawigan to "review all ordinances approved by the sanggunians of component cities and municipalities to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor", among others, the foregoing Municipal Ordinance is in accordance with law;
