WHEREAS, Article III Section 468(a)(1)(i) of RA 7160, provides for the legal basis of the Sangguniang Panlalawigan to “*review all ordinances approved by the sanggunians of component cities and municipalities to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor*”, among others, the foregoing Municipal Ordinance is in accordance with law;


