WHEREAS, the DOLE provides assistance to help the displaced or "to be" displaced workers in coping with the closure or slowing down of operations of companies as a result of economic disruptions and/or the occurrence of natural disasters, calamities or armed conflicts that affect their economic base and to augment the meager income of the underemployed and seasonal workers under its DOLE INTEGRATED LIVELIHOOD & EMERGENCY EMPLOYMENT PROVISION AND THE GOVERNMENT INTERNSHIP PROGRAM, pursuant to the provisions of DO Nos. 173, series of 2017; 204, and 204-A, both series of 2019;

WHEREAS, the DOLE-RO No. XI has been given the responsibility to implement TUPAD Program to enable the displaced workers, underemployed and seasonal wage employment for a period of ten (10) days;
