A RESOLUTION FORWARDING THE APPROPRIATION ORDINANCE NOS. 22 AND 23, ALL SERIES OF 2021, OF THE MUNICIPALITY OF BAGANGA, DAVAO ORIENTAL, TO THE PROVINCIAL LOCAL FINANCE COMMITTEE, THROUGH THE PROVINCIAL BUDGET OFFICER, THIS PROVINCE, FOR TECHNICAL REVIEW AND APPROPRIATE RECOMMENDATION THEREOF, PURSUANT TO SECTION 316(f) OF THE LOCAL GOVERNMENT CODE OF 1991.

- b) Appropriation Ordinance No. 23, Series of 2021, authorizing its CY 2021 General Fund Supplemental Budget No. 4, involving an appropriation of **Eleven Million Six Hundred Thirty One Thousand One Hundred Ninety Pesos (P11,631,190.00)**;

WHEREAS, the subject Appropriation Ordinances were referred to the Committee on Finance, Budget & Appropriations on August 31, 2022, during the 9th Regular Session of the 17th Sangguniang Panlalawigan, and such were docketed as Communication Nos. 17-84-2022 and 17-85-2022, respectively;

WHEREAS, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within 90 days from receipt of copies of such ordinance;

WHEREAS, Section 316(f) of the same Code provides that the Local Finance Committee shall assist the Sangguniang Panlalawigan in the review and evaluation of budget of component cities and municipalities xxx and recommend the appropriate action thereon;

WHEREAS, the reglementary period of review of the foregoing Appropriation Ordinance will end on November 21, 2022;
