**THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:**

**RESOLVED**, to declare Appropriation Ordinance No. 2022-02 of the Municipality of Banaybanay, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the condition that the Fund appropriation for PPAs funded in this budget shall be in accordance with the approved CY 2022 Supplemental Annual Investment Program (SAIP) / Development Plan, pursuant to Sections 287 and 305(i) of RA 7160; DILG MC No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF JMC No. 1, series of 2016, dated November 18, 2016; and DILG-DBM JMC No. 2017-1, dated February 22, 2017. It is understood that the PPAs in the Supplemental AIP in this budget were likewise deliberated and favorably endorsed by the Municipal Development Council to the Sangguniang Bayan for their approval in a resolution form, a copy of the aforesaid shall be attached as supporting document of this budget.

**RESOLVED FURTHER**, to inform the Municipality of Banaybanay, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**MOREOVER**, the Local Government Unit is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under Local Budget Circular No. 112, dated June 10, 2016 in relation to Sections 56(a) and 327 of RA 7160, and Article 110 of its Implementing Rules and Regulations (IRR) which requires that, *“Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said ordinance to the Department of Budget and Management or Sangguniang Panlalawigan for review.”*

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Banaybanay, Davao Oriental, through the Municipal Mayor.


