**A RESOLUTION EXTENDING CONGRATULATIONS AND COMMENDATION TO MINISTER HUSSEIN P. MUÑOZ, FOR BEING RE-APPOINTED BY THE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, HIS EXCELLENCY, FERDINAND R. MARCOS, JR., AS A BANGSAMORO TRANSITION AUTHORITY (BTA) PARLIAMENT MEMBER, AND BRINGING HONOR AND PRIDE NOT ONLY TO THE BANGSAMORO, BUT TO THE PEOPLE OF DAVAO ORIENTAL, FOR HIS EFFORTS AND ADVOCACIES FOR PEACE AND DEVELOPMENT.**

**WHEREAS**, in his decades of service for the Bangsamoro homeland, he is known for his great leadership, profound wisdom and genuine commitment to serving the Bangsamoro. He is one of the great pillars of the Moro Islamic Liberation Front (MILF) as Deputy Chief of Staff of the Bangsamoro Islamic Armed Forces (BIAF);

**WHEREAS**, he was a member of the Bangsamoro Transition Commission (BTC) representing the MILF panel from July 2013 to January 2019, and currently, the Minister

of the Ministry of Public Order and Safety of the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM);

**WHEREAS**, he is also a Parliament Member of the Bangsamoro Transition Authority (BTA) and former Chairman of the Committee on Public Order and Safety as the result of the peace agreements between the Philippine Government and MILF leading to the ratification of the RA 11054 or the Bangsamoro Organic Law;

**WHEREAS**, as a member of the parliament, he authored and co-authored numerous bills, one of which is *“An Act creating the Office of the Bangsamoro Communities outside Bangsamoro Autonomous Region Defining its Powers, functions, and Responsibilities and Appropriating Funds therefore and for other purposes”*. This bill provides access and assistance to Bangsamoro of other ethnic linguistic groups residing outside the Bangsamoro core territories to avail the services and government programs of the Bangsamoro Government;

**WHEREAS**, Minister and Parliament Member Hussein P. Muñoz officially launched its *“GUIDE Program”* or *“GRAND and UNIFIED, INTERVENTIONS for DEVELOPMENT and EMPOWERMENT Program”* last March 1, 2021.

**WHEREAS**, he is currently doing his latest projects in Davao Region, like the TaPANG Project (TangsaPangadi), which aims to help all Madrasahs in the entire region; CAVB Project (Community Assistance for Vulnerable Bangsamoro); educational assistance for college students; and medical assistance;

**WHEREAS**, MP Muñoz, famously known as *“Sonny Davao”* who hails from Lupon, and currently residing at Maputi, Banaybanay, this province, is one of those who strengthened the political party of the Bangsamoro or the United Bangsamoro Justice Party which aims to unite all the Bangsamoro in the entire region;

**WHEREFORE**, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Harold A. Montes, Shella Marie S. Go, Daud V. Linsag, Stephen Paul L. Uy, and Marietta D. Palmera, it was


