A RESOLUTION CONVEYING TO SENATOR CHRISTOPHER LAWRENCE T. GO, CHAIRMAN, COMMITTEE ON HEALTH; CONGRESSMEN NELSON L. DAYANGHIRANG AND CHEENO MIGUEL D. ALMARIO, 1ST AND 2ND DISTRICT REPRESENTATIVES OF DAVAO ORIENTAL, RESPECTIVELY, THE RATIFICATION AND ENDORSEMENT OF THE PROPOSAL TO RE-NATIONALIZE THE DAVAO ORIENTAL PROVINCIAL MEDICAL CENTER (DOPMC) AND PLACE THE SAME UNDER THE DIRECT CONTROL, MANAGEMENT, AND SUPERVISION OF THE DEPARTMENT OF HEALTH (DOH).

WHEREAS, the provincial local government has seen the necessity in building a stronger mechanism to ensure, promote and sustain the delivery of health and safety of its constituents amidst the increasing population and challenges brought by the COVID-19 pandemic;

WHEREAS, to ensure that medical and health care services are appropriately, effectively and efficiently dispensed to all constituents especially to the disadvantaged

and marginalized sectors of the province, a modern, well-maintained and sufficiently equipped Davao Oriental Provincial Medical Center (DOPMC) ably managed by competent medical professionals is needed, therefore, it is more rational to establish a stronger partnership with the Department of Health;

WHEREAS, the fiscal resources of the provincial government have been reduced by low tax collection, huge decrease in the National Tax Allotment share and accumulated loans thus sustainability of the operation of the DOPMC under the provincial government is no longer practicable;

WHEREAS, as nationally managed hospital, DOPMC shall be improved in terms of bed capacity, laboratory equipment and medical supplies, specialized services and proficient medical professionals. The DOPMC shall also strategically serve as the apex hospital of district hospitals in Lupon, Governor Generoso, Manay, and Cateel, and all health care institutions in the province;

WHEREAS, the provincial government will be spared from its annual appropriations for the sustained maintenance, operation and administration of the DOPMC which could be otherwise used for other similarly important development projects and can be made available to fund the implementation of income and/or revenue-generating PPAs. The amount freed up will likewise be made available for the use of the four provincial hospitals of which supervision and management still remain under the provincial government;

WHEREAS, the re-nationalization of DOPMC is beneficial for both the provincial government as an institution and the people as its constituents;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Stephen Paul L. Uy, Harold A. Montes, Rotchie M. Ravelo, Shella Marie S. Go, Daud V. Linsag, and Marietta D. Palmera, it was

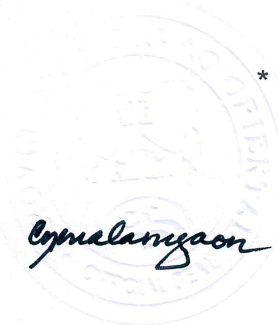


