AN ORDINANCE AMENDING PROVINCIAL ORDINANCE NO. 17-02-08-2022 BY DELETION OF ONE (1) ADMINISTRATIVE AIDE IV (SG-4) POSITION UNDER THE OFFICE OF THE PROVINCIAL GOVERNOR, THEREBY RETAINING THE SAME TOGETHER WITH ITS CORRESPONDING APPROPRIATION FOR SALARIES AND COMPENSATIONS IN CY 2023 PLANTILLA OF PERSONNEL.

WHEREAS, the Local Chief Executive has requested the Sangguniang Panlalawigan for the amendment of Provincial Ordinance No. 17-02-08-2022, approving the abolition of various coterminous positions, particularly one (1) Administrative Aide IV (SG-4) position under the Office of the Provincial Governor;

WHEREAS, the said position was filled-up by an incumbent, however, it was erroneously included in the request for abolition, hence, the need to amend the foregoing ordinance by excluding the said position;

Be it ordained by the 17th Sangguniang Panlalawigan of Davao Oriental, in session duly assembled that:

SECTION 1. ABOLITION OF POSITIONS - the following positions are hereby approved for abolition, as amended:

A) Provincial Governor's Office

- Two (2) Administrative Assistant III (SG-9)
- One (1) Administrative Aide VI (SG-6)

B) SP-Vice Governor's Office

- One (1) Administrative Aide IV (SG-4)
- One (1) Administrative Aide III (SG-3)
- One (1) Administrative Aide I (SG-1)

SECTION 2. REVERSION OF FUNDS – Funding of the abolished positions shall be reverted to Unappropriated Balances of the CY 2023 General Fund of this province.

SECTION 3. RETENTION OF POSITION AND ITS CORRESPONDING FUNDS – The position and funding of One (1) Administrative Aide IV (SG-4) under the Office of the Provincial Governor is hereby retained for CY 2023 Plantilla of Personnel.

SECTION 4. REPEALING CLAUSE – all existing measures with a provision or provisions which are inconsistent with this ordinance, the same are hereby amended or repealed accordingly.

SECTION 5. SEPARABILITY CLAUSE - Should any provision of this Ordinance is found invalid and declared unconstitutional, the rest of the provisions not otherwise affected shall remain effective and enforceable.

SECTION 6. EFFECTIVITY - this Ordinance shall take effect on January 1, 2023.
