A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF SANGGUNIANG BAYAN RESOLUTION NOS. 15-04-07-2022 AND 15-48-09-2022 OF BOSTON, DAVAO ORIENTAL, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, Resolution No. 15-04-07-2022, entitled: "A RESOLUTION REQUESTING FOR EXTENSION OF THE AVAILABILITY PERIOD FOR ONE (1) YEAR OF THE APPROVED P103,000,000.00 LOAN FOR THE ACQUISITION OF HEAVY EQUIPMENT WITH LANDBANK DAVAO DEL NORTE LENDING CENTER", was passed and approved by the Sangguniang Bayan of Boston, on July 25, 2022;

**WHEREAS**, the approval of the Sangguniang Panlalawigan through a resolution relative to the loan agreement between the Municipal Government of Boston and the Land Bank of the Philippines – Davao del Norte Lending Center is among the requirements prior to the release of the loan proceeds;

WHEREAS, Rule XXXIII, Article 395(d) of RA 7160 Implementing Rules and Regulations, provides that: "The authority of an LGU to incur loans, credits, or other forms of indebtedness shall be exercised through a sanggunian resolution, which shall expressly authorize the governor, the city mayor, the municipal mayor, or the punong barangay concerned to negotiate and enter into contract for purposes of securing the loan, credit, or indebtedness applied for.":
