

A RESOLUTION GRANTING ACCREDITATION TO THE BANGSAMORO WOMEN ORGANIZATION OF DAVAO ORIENTAL (BaWOrDo), WITH SATELLITE OFFICE ADDRESS AT ISLAMIC CENTER, MALIPAYON II, POBLACION, LUPON, DAVAO ORIENTAL, CONSIDERING THAT THE SAME HAS COMPLIED ALL THE REQUIREMENTS SET FORTH FOR ACCREDITATION, PURSUANT TO DILG MEMORANDUM CIRCULAR NO. 2022-083, DATED JUNE 15, 2022 AND PROVINCIAL ORDINANCE NO. 14-01-02-2014 AS AMENDED BY PROVINCIAL ORDINANCE NO. 17-01-08-2022.
