A RESOLUTION CONFIRMING THE VALIDITY OF EXECUTIVE ORDER NO. 67, SERIES OF 2022, ISSUED BY THE HONORABLE MICHELLE N. RABAT, CITY MAYOR OF MATI, DAVAO ORIENTAL, RE: “ADOPTING SOCIAL PROTECTION OPERATIONAL FRAMEWORK, SOCIAL PROTECTION STRATEGIES, AND CREATING THE SOCIAL PROTECTION CORE TEAM”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE CITY MAYOR PURSUANT TO ARTICLE I, SECTION 455(b)(2)(iii) OF THE LOCAL GOVERNMENT CODE OF 1991 OR REPUBLIC ACT 7160.

WHEREAS, Article II, Section 9, of the Philippine Constitution, states that: “*The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all*”;


