A RESOLUTION RETURNING THE LETTER OF MR. RAHIMAN L. TAYONGTONG, PROVINCIAL PRESIDENT, BANGSAMORO RADIO ASSISTANCE ON COMMUNICATION AND EMERGENCY SERVICES, INC. (BRACES), WITHOUT ACTION, CONSIDERING THAT THE SAME DOES NOT CONFORM WITH THE REQUIREMENTS SET FORTH FOR ACCREDITATION AS PROVIDED IN SECTION 6.9 OF PROVINCIAL ORDINANCE NO. 14-01-02-2014, AS AMENDED BY PROVINCIAL ORDINANCE NO. 17-01-08-2022.

WHEREAS, Section 6.9 of Provincial Ordinance No. 14-01-02-2014, as amended by Provincial Ordinance No. 17-01-08-2022, provides that: "The Sangguniang Panlalawigan shall accredit the organization based on the following criteria: xxx "Must be accredited /endorsed by the municipality where the entity operates";

WHEREAS, the Provincial President of the Bangsamoro Radio Assistance on Communication and Emergency Services, Inc. (BRACES), forwarded a letter dated August 11, 2022, addressed to the Honorable Vice Governor Niño Sotero L. Uy, Jr., seeking accreditation of their organization from the Sangguniang Panlalawigan. WHEREAS, the said Committee conducted a Committee Meeting on August 22, 2022, to consider the same, however, considering that the said organization has not complied all the requirements set forth for accreditation, specifically Section 6.9 of Provincial Ordinance No. 14-01-02-2014, as amended by Provincial Ordinance No. 17-01-08-2022, hence, returning its application;
