**A RESOLUTION RETURNING THE LETTER OF MS. EMALYN C. LEGAL, EXECUTIVE VICE PRESIDENT OF THE PAMBANSANG KILUSAN NG MGA SAMAHANG MAGSASAKA-MINDANAO (PAKISAMA-MINDANAO) WITHOUT ACTION, CONSIDERING THAT THE SAME DOES NOT CONFORM WITH THE REQUIREMENT SET FORTH FOR ACCREDITATION AS PROVIDED IN SECTION 6.9 OF PROVINCIAL ORDINANCE NO. 14-01-02-2014, AS AMENDED BY PROVINCIAL ORDINANCE NO. 17-01-08-2022.**

**WHEREAS**, Section 6.9 of Provincial Ordinance No. 14-01-02-2014, as amended by Provincial Ordinance No. 17-01-08-2022, provides that: *“The Sangguniang Panlalawigan shall accredit the organization based on the following criteria: xxx “Must be accredited /endorsed by the municipality where the entity operates”;*

**WHEREAS**, the Executive Vice President of the **PAMBANSANG KILUSAN NG MGA SAMAHANG MAGSASAKA-MINDANAO (PAKISAMA-MINDANAO)**, forwarded a letter dated August 15, 2022, addressed to the Honorable Vice Governor Niño Sotero L. Uy, Jr., seeking accreditation of their organization from the Sangguniang Panlalawigan. The same was docketed as Communication No. 17-87-2022;


