A RESOLUTION ENDORSING TO THE HONORABLE CORAZON N. MALANYAON, PROVINCIAL GOVERNOR, THROUGH THE PROVINCIAL ENGINEER’S OFFICE, THE HEREIN SANGGUNIANG BARANGAY RESOLUTION NO. 49, SERIES OF 2022, OF BARANGAY CRISPIN DELA CRUZ, MUNICIPALITY OF GOVERNOR GENEROSO, THIS PROVINCE, FOR WHATEVER ACTIONS DEEMED APPROPRIATE THEREOF.

WHEREAS, Barangay Kagawad Sixto V. Calugay of Barangay Crispin Dela Cruz, Governor Generoso, in his letter, addressed to the Vice Governor Niño Sotero L. Uy, Jr., duly noted by the Punong Barangay, Hon. Alicerio C. Andas, forwarded Resolution No. 49, series of 2022;

WHEREAS, in the said letter, they requested for a favorable attention and consideration of Barangay Council Resolution No. 49, series of 2022, entitled: “A Resolution requesting Hon. Corazon N. Malanyaon, Governor, Davao Oriental thru the Presiding Officer, Hon. Niño Sotero L. Uy, Sangguniang Panlalawigan to fastrack the

declaration of the road portion from Boundary Sergio Osmeña Sr. to Barangay Tibanban approximately 2.5 kilometers more or less into Barangay Road of Crispin Dela Cruz, Governor Generoso, this Province”;

WHEREAS, the request for the declaration of the aforementioned road portions into a barangay road is purposely for the concerned barangay to exercise the collection of local sources of income within their territorial jurisdiction;

WHEREAS, barangay roads refer to the rural roads located either outside of the urban area of a city or outside industrial, commercial or residential subdivisions which act as feeder or farm-to-market roads, and which are not otherwise classified as national, provincial, city or municipal roads. Roads located outside the poblacion area of a municipality and those roads located outside the urban area of a city to be designated as such by the Barangay Council concerned;

WHEREAS, in support to the request of the Barangay Council and likewise to provide specific recommendation and guidance to the concerned parties, hence the passage of this resolution;

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Harold A. Montes, Shella Marie S. Go, Daud V. Linsag, Marietta D. Palmera, Andy A. Monday, and Ronald T. Lara, Jr., it was
