A RESOLUTION AUTHORIZING THE HONORABLE PROVINCIAL GOVERNOR CORAZON N. MALANYAON, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH CITY/MUNICIPAL MAYORS OF THIS PROVINCE, RELATIVE TO THE IMPLEMENTATION OF UNIVERSAL HEALTH CARE INTEGRATION SITES.

WHEREAS, presented for consideration before the August Body is an urgent letter from the Honorable Governor Corazon N. Malanyaon, dated October 17, 2022, addressed to the Honorable Members of the 17<sup>th</sup> Sangguniang Panlalawigan thru the Vice Governor, Honorable Niño Sotero L. Uy, Jr., for the passage of a resolution authorizing her for the aforementioned subject matter, docketed as Communication No. 17-156-2022;

WHEREAS, her letter was supported with Provincial Health Board Resolution No. 05, 2022, requesting the Sangguniang Panlalawgian for a passage of the above stated resolution;

WHEREAS, the First and Second Parties are conscious of the endeavor to integrate local health systems into province-wide health systems to ensure the effective and efficient delivery of population-based and individual-based health services by virtue of Section 19 of Republic Act 11223 or the Universal Health Care (UHC) Act of 2019;

WHEREAS, it is the earnest intent of both parties to operationalize and fully implement all local health system reforms endeavored in the UHC Act, particularly those in relation to province-wide health systems integration, the establishment and management of a Special Health Fund and the shift to network-based contracting of health care providers as a strategy to achieve its health system aims;

WHEREAS, Chapter III, Section 465(b)(1)(vi) of the Local Government Code of 1991, states among others that: "the Provincial Governor, as the chief executive of the provincial government, shall represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance";

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Stephen Paul L. Uy, Rotchie M. Ravelo, Shella Marie S. Go, Harold A. Montes, Daud V. Linsag, Marietta D. Palmera, and Eleuterio C. Manaytay, it was
