Mabini, Secretary to the Sangguniang Panlungsod of Mati, Davao Oriental, in his letter dated October 4, 2022, submitted various City Ordinances, including City Ordinance No. 547, series of 2022, for review of the 17th Sangguniang Panlalawigan, docketed as Communication No. 17-149-2022;

WHEREAS, the said Ordinance was enacted by the 7th Sangguniang Panlungsod on September 13, 2022, purposely to provide additional guidelines for its better implementation, which promote inclusiveness and accelerate the economic recovery of the City of Mati, by providing loan assistance to Micro & Small Enterprise greatly affected by COVID-19 pandemic;
