Mabini, Secretary to the Sangguniang Panlungsod of Mati, Davao Oriental, in his letter dated October 4, 2022, submitted various City Ordinances, including City Ordinance No. 547, series of 2022, for review of the 17<sup>th</sup> Sangguniang Panlalawigan, docketed as Communication No. 17-149-2022;


