A RESOLUTION FORWARDING THE APPROPRIATION ORDINANCES OF THE CITY OF MATI, AND MUNICIPALITIES OF GOVERNOR GENEROSO AND CARAGA, ALL OF THIS PROVINCE, TO THE PROVINCIAL LOCAL FINANCE COMMITTEE, THROUGH THE PROVINCIAL BUDGET OFFICER, FOR TECHNICAL REVIEW AND APPROPRIATE RECOMMENDATION THEREOF, PURSUANT TO SECTION 316(f) OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Appropriation Ordinance No. 05, series of 2022, of the City of Mati, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 05, involving an appropriation of <u>Fifty Million Three Hundred Seventy Thousand Two Hundred Thirty Four Pesos and 88/100 (P50,370,234.88)</u>, was submitted to this Sanggunian for review on September 28, 2022, and the same was docketed as Communication No. 17-126-2022;

WHEREAS, Appropriation Ordinance No. 2 of the Municipality of Governor Generoso, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 2, involving an appropriation of <u>Fifteen Million Four Thousand Seven Hundred</u>

Ninety Three Pesos (P15,004,793.00), was submitted to this Sanggunian for review on September 29, 2022, and the same was docketed as Communication No. 17-127-2022;

WHEREAS, Appropriation Ordinance No. 04, series of 2021, of the Municipality of Caraga, Davao Oriental, authorizing its CY 2022 General Fund Annual Budget, involving an appropriation of <a href="https://doi.org/10.1036/nnews.com/">Three Hundred Forty Four Million Four Hundred Ninety Eight Thousand Nine Hundred Forty Five Pesos (P344,498,945.00)</a>, was submitted to this Sanggunian for review on October 6, 2022, and the same was docketed as Communication No. 17-136-2022;

**WHEREAS,** the subject Appropriation Ordinances were referred to the Committee on Finance, Budget & Appropriations on October 12, 2022 and October 17, 2022, during the 15<sup>th</sup> and 16<sup>th</sup> Regular Sessions of the 17<sup>th</sup> Sangguniang Panlalawigan, respectively;

WHEREAS, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within 90 days from receipt of copies of such ordinance;

WHEREAS, the reglementary period of review of the foregoing Appropriation Ordinances will end on December 27, 2022, December 28, 2022, and January 4, 2023, respectively;

WHEREAS, Section 316(f) of the same Code provides that the Local Finance Committee shall assist the Sangguniang Panlalawigan in the review and evaluation of budget of component cities and municipalities xxx and recommend the appropriate action thereon;

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Stephen Paul L. Uy, Shella Marie S. Go, Daud V. Linsag, Harold A. Montes, Rotchie M. Ravelo, Anna Cheryl N. Castro, Art Benjie C. Bulaong, and Eleuterio C. Manaytay, it was
