WHEREAS, the subject City Ordinance provides the reallocation of the abovementioned position purposely to address the emerging needs of human resources of the concerned departments/offices that will promote and enhance over-all productivity of the City Government of Mati;

WHEREAS, DBM Budget Circular Nos. 2004-3 and 2018-4 provides that reallocation is a conversion of positions to their respective appropriate generic administrative class titles. Moreover, as provided under the 2017 ORAOHRA, transfer is the movement of employee from one position to another which is of equivalent rank, level or salary xxx from one department or agency to another. Whereas, detail is the temporary movement of an employee from one department or agency to another which does not involve a reduction in rank, status or salary;

WHEREAS, in exercising the prescribed functions of the Sanggunian to review all ordinances approved by the Sanggunians of component cities and municipalities to determine whether these are within the scope of the prescribed powers of the sanggunians, among others, the subject City Ordinance is found such that the same approved the movement of the abovementioned position from one office to another;
