

MALANYAON, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH — DAVAO CENTER FOR HEALTH DEVELOPMENT OFFICE XI, REPRESENTED BY ITS REGIONAL DIRECTOR DR. ANNABELLE P. YUMANG, MCH, CESO III, RELATIVE TO THE IMPLEMENTATION OF POST-RESIDENCY DEPLOYMENT PROGRAM TO DAVAO ORIENTAL PROVINCIAL MEDICAL CENTER.

WHEREAS, presented for consideration before the August Body is an urgent letter-request from the Honorable Governor Corazon N. Malanyaon, dated November 7, 2022, addressed to the Honorable Members of the 17th Sangguniang Panlalawigan thru the Vice Governor, Honorable Niño Sotero L. Uy, Jr., for the passage of a resolution authorizing her for the aforementioned subject matter, docketed as Communication No. 17-185-2022;

WHEREAS, Chapter III, Section 465(b)(1)(vi) of the Local Government Code of 1991, states that the Provincial Governor, as the chief executive of the provincial
