MICHELLE MARIE DENISE N. RABAT, THE FULL POWER AND AUTHORITY TO REPRESENT THE CITY GOVERNMENT OF MATI, PROVINCE OF DAVAO ORIENTAL TO SIGN AND EXECUTE DOCUMENTS RELATED TO THE BORROWING; AND APPROVING THE TERMS AND CONDITIONS SET FORTH BY THE LENDING INSTITUTION”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD PURSUANT TO APPLICABLE PROVISIONS OF RA 7160 OR THE LOCAL GOVERNMENT CODE OF 1991;




