**A RESOLUTION FORWARDING THE APPROPRIATION ORDINANCES OF THE MUNICIPALITIES OF MANAY AND SAN ISIDRO, AND THE CITY OF MATI, ALL OF THIS PROVINCE, TO THE PROVINCIAL LOCAL FINANCE COMMITTEE, THROUGH THE PROVINCIAL BUDGET OFFICER, FOR TECHNICAL REVIEW AND APPROPRIATE RECOMMENDATION THEREOF, PURSUANT TO SECTION 316(f) OF THE LOCAL GOVERNMENT CODE OF 1991.**

**WHEREAS**, Appropriation Ordinance No. 2022-20-02 of the Municipality of Manay, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 01, involving an appropriation of **Thirty Seven Million Eight Hundred Sixty Nine Thousand Nine Hundred Four and 67/100 (P37,869,904.67)**, was submitted to this Sanggunian for review on October 18, 2022, and the same was docketed as Communication No. 17-155-2022;

**WHEREAS**, Appropriation Ordinance No. 05-17-2022 of the Municipality of San Isidro, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 05, involving an appropriation of **One Million One Hundred Twelve Thousand Pesos (P1,112,000.00)**, was submitted to this Sanggunian for review on October 28, 2022, and the same was docketed as Communication No. 17-171-2022;

**WHEREAS**, Appropriation Ordinance No. 06, series of 2022, of the City of Mati, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 06, involving an appropriation of **Fifteen Million Five Hundred Ninety Two Thousand Six Hundred Ninety Pesos and 92/100 (P15,592,690.92)**, was submitted to this Sanggunian for review on November 7, 2022, and the same was docketed as Communication No. 17-180-2022;

**WHEREAS**, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within 90 days from receipt of copies of such ordinance;

**WHEREAS**, the reglementary period of review of the foregoing Appropriation Ordinances will end on January 16, 2023, January 26, 2023 and February 3, 2023, respectively;

**WHEREAS**, Section 316(f) of the same Code provides that the Local Finance Committee shall assist the Sangguniang Panlalawigan in the review and evaluation of budget of component cities and municipalities xxx and recommend the appropriate action thereon;

**WHEREFORE**, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Rotchie M. Ravelo, Harold A. Montes, Daud V. Linsag, and Art Benjie C. Bulaong, it was




