A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2022-04 OF THE SANGGUNIANG BAYAN OF BANAYBANAY, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE REGULATING THE SALE OF VOLATILE SUBSTANCE/SOLVENT AND PROHIBITING HARDWARE STORES AND OTHER ESTABLISHMENTS WITHIN THE MUNICIPALITY TO SELL TO MINORS SUCH CHEMICAL COMPOUND OR ITS DERIVATIVES AND PROVIDING PENALTIES THEREOF", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.

WHEREAS, the Sangguniang Bayan of Banaybanay, Davao Oriental, submitted Municipal Ordinance No. 2022-04 to the Sangguniang Panlalawigan for an appropriate action;

minors which are commonly used as an alternative to mind altering drugs, within the territorial jurisdiction of the Municipality unless otherwise accompanied by his/her parents or persons above 18 years old;
