A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2022-06 OF THE SANGGUNIANG BAYAN OF BANAYBANAY, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE REQUIRING ALL HOUSEHOLDS IN THE MUNICIPALITY OF BANAYBANAY TO COMPLY TO ZERO OPEN DEFECATION (ZOD), PROVIDING FOR ITS GUIDELINES AND PENALTIES FOR VIOLATION AND APPROPRIATING FUNDS THEREFOR", CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF RA 7160 OR THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Mr. Eden Celestino S. Cacho, Secretary to the Sangguniang Bayan of Banaybanay, Davao Oriental, in his letter, dated October 25, 2022, submitted Municipal Ordinance No. 2022-06, for legislative review of the Sangguniang Panlalawigan;

WHEREAS, the said ordinance requires for every household within the territorial jurisdiction of the Municipality of Banaybanay to have a sanitary toilet in their respective homes and shall ensure proper disposal of human waste in order to prevent the occurrence of diseases caused by open defecation;

WHEREAS, Municipal Mayor Lemuel Ian M. Larcia approved Municipal Ordinance No. 2022-06 on October 25, 2022 which was enacted by the 16th Sangguniang Bayan of Banaybanay on its 13th Regular Session held on October 4, 2022;
