**A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 554, SERIES OF 2022, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE PRESCRIBING THE FEES AND CHARGES FOR THE OPERATION OF THE SIXTEEN (16) STALLS WITHIN THE MAYOR FGR PARK AND BAYWALK”, SUBJECT TO THE EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.**

**WHEREAS**, Section 186 of the Local Government Code of 1991 or RA 7160 states that: “Local government units may exercise the power to levy taxes, fees or charges xxx”;

**WHEREAS**, Mr. Juvy L. Mabini, Secretary to the Sangguniang Panlungsod of Mati, Davao Oriental, in his letter, dated November 8, 2022, submitted City Ordinance No. 554, series of 2022, for review of the 17<sup>th</sup> Sangguniang Panlalawigan, docketed as Communication No. 17-189-2022;

**WHEREAS**, the operation of the 16 stalls within the Mayor FGR Park and Baywalk is to promote Mati's products and further augment the source of revenue to the City Government of Mati;




