A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 303-17-2022 OF THE SANGGUNIANG BAYAN OF SAN ISIDRO, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE AMENDING BY INSERTION MUNICIPAL ORDINANCE NO. 263-17-2018A, OTHERWISE KNOWN AS SAN ISIDRO CHILDREN’S CODE OF 2018”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF R.A. 7160 OR THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Mr. Melvin B. Lubitaña, Secretary to the Sangguniang Bayan of San Isidro, Davao Oriental, in his letter, dated October 28, 2022, submitted Municipal Ordinance No. 303-17-2022, for legislative review of the Sangguniang Panlalawigan;

WHEREAS, the said ordinance is an amendment of Municipal Ordinance No. 263-17-2018A, otherwise known as the San Isidro Children’s Code of 2018, which was

enacted on June 19, 2019, by adding some premises and Sections specifically under Article 5 thereof;

WHEREAS, the amendments are based on the current laws that need to be appropriately incorporated in the said code;

WHEREAS, Municipal Mayor Maria Angelica T. Go approved Municipal Ordinance No. 303-17-2022 on October 20, 2022 which was enacted by the 17th Sangguniang Bayan of San Isidro on its 14th Regular Session held on October 11, 2022;

WHEREAS, upon premises considered, it is the recommendation of the Sangguniang Panlalawigan to the Sangguniang Bayan, subject for consideration, by amending the title of the municipal ordinance into: "An Ordinance Amending Municipal Ordinance No. 263-17-2018A, otherwise known as "San Isidro Children's Code of 2018", by adding premises and Sections in Article 5 thereof;

WHEREFORE, on motion of SP Member Shella Marie S. Go, duly and jointly seconded by SP Members Daud V. Linsag, Stephen Paul L. Uy, Rotchie M. Ravelo, Harold A. Montes, Art Benjie C. Bulaong, and Marietta D. Palmera, it was
