**WHEREAS**, Appropriation Ordinance No. 07, series of 2022, of the City of Mati, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 07, involving an appropriation of **Twenty Four Million One Hundred Ninety Thousand Six Hundred Five Pesos and 78/100 (P24,190,605.78)**, was submitted to this Sanggunian for review on November 10, 2022, and the same was docketed as Communication No. 17-190-2022;

**WHEREAS**, Appropriation Ordinance No. 08, series of 2022, of the City of Mati, Davao Oriental, authorizing its FY 2023 General Fund Annual Budget, involving an

appropriation of **One Billion Five Hundred Seventy Five Million Three Hundred Forty Seven Thousand Eight Hundred Eighty Six Pesos (P1,575,347,886.00)**, was submitted to this Sanggunian for review on November 14, 2022, and the same was docketed as Communication No. 17-195-2022;

**WHEREAS**, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within 90 days from receipt of copies of such ordinance;

**WHEREAS**, the reglementary period of review of the foregoing Appropriation Ordinances will end on February 3, 2023, and February 10, 2023, respectively;

**WHEREAS**, Section 316(f) of the same Code provides that the Local Finance Committee shall assist the Sangguniang Panlalawigan in the review and evaluation of budget of component cities and municipalities xxx and recommend the appropriate action thereon;
