**EXECUTIVE ORDER NO. 13**

**RECONSTITUTING THE PROVINCIAL COUNCIL ON DISABILITY AFFAIRS (PCDA)  
OF DAVAO ORIENTAL**

**WHEREAS**, the Provincial Council on Disability Affairs Office shall recommend policies concerning the development and empowerment of Persons with Disabilities through ordinance and resolutions and ensure that appropriate funds are allocated for the purpose.

**WHEREAS**, the Provincial Council on Disability Affairs Office shall formulate and approve the Plan of Action (ROADMAP) to ensure the inclusion of targets and budget. The Provincial Council on Disability Affairs shall be furnished a copy for its inclusion in the Philippine Plan of Action.

**WHEREAS**, the Provincial Council on Disability Affairs Office shall monitor, review and evaluate programs, projects and activities on disability implemented by the different agencies and offices within the province.

**WHEREAS**, the Provincial Council on Disability Affairs Office shall ensure the inclusion of Disability Data in the Management Information System of the Province.

**WHEREAS**, the Provincial Council on Disability Affairs Office shall document best practices and furnish to the concerned agencies like DILG, DOH, DSWD, RDC, RCDA and other offices.

**WHEREAS**, the Provincial Council on Disability Affairs Office shall approve the adaption of the Non-Handicaping Environment (NHE) strategy/approach to the Chairperson (Local Chief Executive) with the concurrence of the Co-Chairperson (Sangguniang Panlalawigan).

**WHEREAS**, the Provincial Council on Disability Affairs Office shall network with other agencies and offices for the Local Committees for continuous professional growth and to replicate to the Local Committee in the City and Municipal Levels.

**WHEREAS**, the Provincial Council on Disability Affairs Office shall advocate and raise awareness of the community through the conduct of disability-related events such as the National Disability Prevention and Rehabilitation (NDPR) Week Celebration, International Day of the Person with Disabilities, White Cane and other related events.

**WHEREAS**, the Secretariat Support shall be provided by the Provincial Persons with Disability Affairs Office. They shall be responsible for the documentation of proceedings of meetings, preparation and submission of reports and other necessary documents needed by the council.

**WHEREAS**, The Provincial Government shall provide funds for the operation of the Provincial Council on Disability Affairs.

**NOW THEREFORE, I CORAZON N. MALANYAON**, by the virtue of the power vested in me by law, do hereby order the Provincial Council on Disability Affairs to be reconstituted.

**SECTION 1. COMPOSITION.** This council shall be composed of the following:
