



**EXECUTIVE ORDER NO. 26 SERIES OF 2022**

**AN ORDER CREATING PROVINCIAL LOCAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN REVIEW TEAM FOR THE PROVINCE OF DAVAO ORIENTAL**

**WHEREAS**, Section 2 of RA 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 states that it is the policy of the state to develop, promote and implement a comprehensive Disaster Risk Reduction and Management Plan that aims to strengthen the capacity of the Local Government Units, together with partner stakeholders, to build the disaster resilience of communities, and to institutionalize arrangements and measures for reducing disaster risks, including projected climate risks, and enhancing disaster preparedness and response capabilities at all levels;

**WHEREAS**, it is also the policy of the state to adopt and implement a coherent, comprehensive, integrated, efficient and responsive disaster risk reduction program incorporated in the development plans at various level of government;

**WHEREAS**, Section 9 (e) of RA 10121 states that it is the function of the Office of Civil Defense (OCD) to review and evaluate the Local Disaster Risk Reduction and Management Plans (LDRRMPs) to facilitate the integration of disaster risk reduction measures into local Comprehensive Development Plans (CDPs) and Comprehensive Land-Use Plans (CLUP);

**WHEREAS**, NDRRMC Memorandum Circular No. 147 series of 2017 dated December 1, 2017 prescribed guidelines in the conduct of review and evaluation of the Local Disaster Risk Reduction and Management Plans (LDRRMPs) pursuant to Section 9 (e) of RA 10121 and providing the prescribed organization and membership of LDRRMP Review Team;

**WHEREAS**, NDRRMC Memorandum Circular No. 13 series of 2018 dated January 24, 2018 amending the prescribes guidelines in the conduct of Local Disaster Risk Reduction and Management Plans by expanding the membership of the LDRRMP Review Team;

**WHEREAS**, to ensure that the City/Municipal Local DRRM Plans is aligned with the higher DRRM Plan, to guarantee that the DRRM-CCA programs, projects and activities (PPAs) in the City/Municipal LDRRM Plans are appropriate to the hazards present in the LGUs, to ensure that the Sanggunian approved Annual Investment Plan (AIP) for DRRM-CCA of concerned LGU is consistent with their LDRRM Plan and to guarantee the judicious utilization of the Local DRRM Fund;

**NOW, THEREFOR I, CORAZON T. NUÑEZ-MALANYAON**, Provincial Governor of this Province, by virtue of the powers vested in me by law, do hereby order the creation of the Provincial Local Disaster Risk Reduction and Management Plan (LDRRMP) Review Team and prescribing their functions to wit:

**SECTION 1. COMPOSITION**

The Provincial Local Disaster Risk Reduction and Management Plan Review Team for the Province of Davao Oriental is hereby created and shall have the following composition:

## SECTION 2. DUTIES AND FUNCTIONS.

The Provincial LDRRMP Review Team shall perform the following functions:

1. Conduct review of the City and Municipal DRRM Plans pursuant to the prescribed guidelines stated under NDRRMC Memorandum Circular No. 147 series of 2017 and other Review tool and Checklist that the NDRRMC prescribes;
2. Shall issue a recommendation address to the Chairperson of the RDRRMC for the issuance of the certificate of the concerned LGUs once the criteria of the LDRRMP review have been complied;
3. Shall record the results of the review and shall furnish a copy to the office of the Provincial Governor, the Provincial DRRM Council and to the office of Civil Defense RO XI.

## SECTION 3. FUNDING

Funds necessary to carry out the review shall be taken from the 5% Provincial Disaster Risk Reduction and Management Fund (PDRRMF) subject to regular budgeting and auditing rules and regulations.

## SECTION 4. EFFECTIVITY

This order shall take effect immediately upon signing hereof and shall remain in force unless revoked or amended accordingly.
