**A RESOLUTION REQUESTING THE HONORABLE CHEENO MIGUEL D. ALMARIO, 2<sup>ND</sup> DISTRICT CONGRESSMAN OF THE PROVINCE OF DAVAO ORIENTAL, TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF A 2-STOREY 6-CLASSROOM SCHOOL BUILDING OF ERNESTO D. VIOLAN NATIONAL HIGH SCHOOL, LOCATED AT BARANGAY SAN ISIDRO, MUNICIPALITY OF LUPON, PROVINCE OF DAVAO ORIENTAL.**

**WHEREAS**, Section 2 of Republic Act 9155 states that: *“It is hereby declared the policy of the State to protect and promote the right of all citizens to quality basic education and to make such education accessible to all by providing all Filipino children a free and compulsory education in the elementary level and free education in the high school level. Xxx”;*

**WHEREAS**, the State recognizes the fact that the quality of education in the country suffers due to poor school facilities and services;

**WHEREAS**, Ernesto D. Violan National High School, which officially operates last October 5, 2022, by virtue of Special Order No. R-XI-013, s. of 2022, issued by the Regional Director of the Department of Education, only accommodates Grade 7 students due to inadequate school buildings and classrooms;

**WHEREAS**, some classes of the said school were conducted at a borrowed vacant classroom in Ernesto D. Violan Elementary School, while the makeshift classroom building will also be constructed, just to accommodate the increasing number of students from higher secondary level;

**WHEREAS**, considering that the existing school building and classrooms cannot accommodate the increasing number of students, it is deemed necessary to construct the additional school building for this purpose to accommodate grade 7 to grade 10 levels of the said school;

**WHEREFORE**, on motion of SP Member Harold A. Montes, duly and jointly seconded by SP Members Daud V. Linsag, Stephen Paul L. Uy, Rotchie M. Ravelo, and Shella Marie S. Go, it was




