**WHEREAS**, Chapter III, Section 7(e) of Republic Act 8371, states that: “*The rights of ownership and possession of ICCs/IPs to their ancestral domains shall be recognized and protected. Such rights shall include: xxx Right to regulate the entry of migrant settlers and organizations into the domains*”;
