A RESOLUTION FORWARDING APPROPRIATION ORDINANCE NO. 02, SERIES OF 2022, OF THE MUNICIPALITY OF TARRAGONA, DAVAO ORIENTAL, TO THE LOCAL FINANCE COMMITTEE, THROUGH THE PROVINCIAL BUDGET OFFICER, THIS PROVINCE, FOR TECHNICAL REVIEW AND APPROPRIATE RECOMMENDATION THEREOF, PURSUANT TO SECTION 316(f) OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Appropriation Ordinance No. 02, series of 2022, of the Municipality of Tarragona, Davao Oriental, authorizing its FY 2023 General Fund Annual Budget, involving an appropriation of **One Hundred Seventy Seven Million Six Hundred Five Thousand Three Hundred Eighty Seven Pesos (P177,605,387.00)**, was submitted to this Sanggunian for review on November 16, 2022, and the same was docketed as Communication No. 17-199-2022;

WHEREAS, the subject Appropriation Ordinance was referred to the Committee on Finance, Budget & Appropriations on November 16, 2022, during the 21st Regular Session of the 17th Sangguniang Panlalawigan;


