A RESOLUTION CONFIRMING THE ACCEPTANCE AND CONTINUANCE OF THE DOTR-FUNDED MATI AIRPORT DEVELOPMENT PROJECT BY THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL DULY REPRESENTED BY ITS NEWLY-INSTALLED PROVINCIAL GOVERNOR, HONORABLE CORAZON N. MALANYAON, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, the Provincial Government of Davao Oriental (PLGU), represented by then Provincial Governor and incumbent 1<sup>st</sup> District Representative, Congressman Nelson L. Dayanghirang, entered into and executed a Memorandum of Agreement (MOA) with the Department of Transportation (DOTr), represented by its Undersecretary for Aviation and Airports, Capt. Manuel Antonio L. Tamayo, on December 8, 2020, for the implementation of the Mati Airport Development Project (Mati Airport Site Acquisition) with a total allocated amount of Two Hundred Million Pesos (P200,000,000.00) under the DOTr General Appropriate Act (GAA) CY 2019;

WHEREAS, given the local governance transition that transpired following the May 2022 National and Local Election, the DOTr – as among its prerequisites for the

release of the remaining funds (2<sup>nd</sup> Tranche) to the PLGU amounting to Twenty Million Pesos (P20,000,000.00) — requires a pertinent resolution of the concerned Local Sanggunian that shall signify the intention of the newly-elected PLGU officials to accept and continue the project, as specified in the furnished copy of a letter, dated November 29, 2022, of Engr. Santy M. Zapata, Project Manager, Dotr-Project Management Services;

WHEREAS, considering the significance of the Mati Airport modernization and the potentially enormous impact of the project on the Province's local economy as an alternate airport to the Francisco Bangoy International Airport (Davao International Airport), the PLGU, duly represented by its Provincial Governor, Honorable Corazon N. Malanyaon, manifested its desire to include the project among its priority PPAs and to expedite the acquisition of the affected lots and the improvements found thereon in accordance with the provisions of Republic Act No. 10752 also known as "The Right-of-Way Act";

WHEREFORE, on motion of SP Member Daud V. Linsag, duly and jointly seconded by SP Members Anna Cheryl N. Castro, Marietta D. Palmera, Andy A. Monday, Stephen Paul L. Uy, Rotchie M. Ravelo, and Harold A. Montes, it was
