A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 04-2022 OF THE SANGGUNIANG BAYAN OF CATEEL, DAVAO ORIENTAL, ENTITLED: "PROVIDING FOR THE CONTROL AND ELIMINATION OF HUMAN AND ANIMAL RABIES IN THE MUNICIPALITY OF CATEEL, DAVAO ORIENTAL AND PROVIDING FUNDS AND PENALTIES THEREOF", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.

WHEREAS, Section 447(a)(1) of the Local Government Code of 1991 states that the sangguniang bayan shall enact ordinances for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the same code;

WHEREAS, Section 7 of the Republic Act No. 9482, otherwise known as "Anti-Rabies Act of 2007", mandates the responsibilities of the local government units to support the control and elimination of human and animal rabies program of the national government in their respective locality;

WHEREAS, the Municipal Ordinance No. 04-2022 provides for the control and elimination of human and animal rabies in the said municipality and to address the
