A RESOLUTION FORWARDING APPROPRIATION ORDINANCE NO. 06-17-2022 OF THE MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL, TO THE LOCAL FINANCE COMMITTEE, THROUGH THE PROVINCIAL BUDGET OFFICER, THIS PROVINCE, FOR TECHNICAL REVIEW AND APPROPRIATE RECOMMENDATION THEREOF, PURSUANT TO SECTION 316(f) OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Appropriation Ordinance No. 06-17-2022 of the Municipality of San Isidro, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 06, involving an appropriation of <u>Four Hundred Three Thousand Pesos</u> (P403,000.00), was submitted to this Sanggunian for review on November 25, 2022, and the same was docketed as Communication No. 17-207-2022;

**WHEREAS,** the subject Appropriation Ordinance was referred to the Committee on Finance, Budget & Appropriations on December 1, 2022, during the 22<sup>nd</sup> Regular Session of the 17<sup>th</sup> Sangguniang Panlalawigan;
