A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 02-2022 OF THE MUNICIPALITY OF CATEEL, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 02-2022 of the Municipality of Cateel, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 02, involving an appropriation of <a href="Million Seven Hundred Ninety-Five Thousand Eight Hundred Seventy Pesos & 77/100">Mineteen Million Seven Hundred Ninety-Five Thousand Eight Hundred Seventy Pesos & 77/100</a> (P19,795,870.77), was submitted to this Sanggunian for review on August 31, 2022, pursuant to the provisions of Republic Act No. 7160:

RESOLVED, to declare Appropriation Ordinance No. 02-2022 of the Municipality of Cateel, Davao Oriental, OPERATIVE IN ITS ENTIRETY, as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the condition that the Re-appropriation for the 20% Development Fund shall be in accordance with the approved CY 2022 Supplemental Annual Investment Program (SAIP) Development Plan, pursuant to Sections 287 and 305(i) of RA 7160, DILG Memorandum Circular No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, series of 2016, dated November 18, 2016; and DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017. It is understood that the projects in the Supplemental AIP are likewise deliberated and favorably endorsed by the Municipal Development Council to Sangguniang Bayan for their approval in a Resolution Form.

**RESOLVED FURTHER,** to inform the Municipality of Cateel, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**RESOLVED FINALLY,** to send a copy of this Resolution to the Sangguniang Bayan of Cateel, Davao Oriental, through the Municipal Mayor.
