WHEREAS, Appropriation Ordinance No. 03-2022 of the Municipality of Cateel, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 03, involving an appropriation of <u>Thirteen Million Six Hundred Seventy-Three Thousand Nine Hundred Five Pesos and 58/100 (P13,673,905.58)</u>, was submitted to this Sanggunian for review on December 2, 2022, and the same was docketed as Communication No. 17-221-2022;

WHEREAS, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within 90 days from receipt of copies of such ordinance;

WHEREAS, the reglementary period of review of the foregoing Appropriation Ordinances will end on March 1, 2023 and March 2, 2023, respectively;
