WHEREAS, under mutual covenants set forth in the attached Memorandum of Understanding between parties, the implementation of projects and activities to address emergencies during calamities shall adhere to Section 53 IRR-A, RA 9184 and subject to the usual accounting and auditing rules and regulations governing government transaction;

WHEREAS, Chapter III, Section 465(b)(1)(vi) of the Local Government Code of 1991, states among others that: *“the Provincial Governor, as the chief executive of the provincial government, shall represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance”*;




