**A RESOLUTION FORWARDING THE APPROPRIATION ORDINANCE NO. 2022-04 OF THE MUNICIPALITY OF BANAYBANAY, DAVAO ORIENTAL, TO THE PROVINCIAL LOCAL FINANCE COMMITTEE, THROUGH THE PROVINCIAL BUDGET OFFICER, FOR TECHNICAL REVIEW AND APPROPRIATE RECOMMENDATION THEREOF, PURSUANT TO SECTION 316(f) OF THE LOCAL GOVERNMENT CODE OF 1991.**

**WHEREAS**, Appropriation Ordinance No. 2022-04 of the Municipality of Banaybanay, Davao Oriental, authorizing its CY 2022 Supplemental Budget No. 04, involving an appropriation of **Five Million One Hundred Seventy-Six Thousand Five Pesos and 36/100 (P5,176,005.36)**, was submitted to this Sanggunian for review on December 9, 2022, and the same was docketed as Communication No. 17-229-2022;

**WHEREAS**, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within 90 days from receipt of copies of such ordinance;
