**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2, SERIES OF 2022, OF THE MUNICIPALITY OF GOVERNOR GENEROSO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.**

**WHEREAS**, Appropriation Ordinance No. 2, series of 2022, of the Municipality of Governor Generoso, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 2, involving an appropriation of **Fifteen Million Four Thousand Seven Hundred Ninety-Three Pesos (P 15,004,793.00)**, was submitted to this Sanggunian for review on September 29, 2022, pursuant to the provisions of Republic Act No. 7160;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

**RESOLVED**, to declare Appropriation Ordinance No. 2, series of 2022, of the Municipality of Governor Generoso, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following condition that the LGU shall adapt the measure of not filling-up vacant funded positions except for mandatory one, and no creation of positions, in order to reduce the aforesaid excess of 6% in the amount equivalent to that which is within the exact 45% limitation, pursuant to DBM LBC No. 98, dated October 14, 2011; and Section 325(a) of RA 7160.

**RESOLVED FURTHER**, to inform the Municipality of Governor Generoso, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Governor Generoso, Davao Oriental, through the Municipal Mayor.


